# GUNAA-DC Elections: December

GUNAADC.com

## President

- The President shall be responsible for developing Chapter priorities, execution strategy, and presiding over chapter meetings.
- He/she shall serve as liaison between the Chapter, Association and the University.
- The President or his/her designee shall represent the Chapter in business matters with the Association and the University.
- He/She shall serve as chairperson of the Executive Committee and may call a meeting of the Board of Directors whenever necessary.
- In the absence of the President or in case the President is incapacitated or resigns, the Vice-President shall assume the duties of the President.
- The President shall resume his/her duties when he/she is no longer incapacitated.
- The President may call special meetings of the Chapter when requested in writing by the majority of the Executive Committee.
- The President shall perform the duties prescribed by GUNAA Bylaws and by the parliamentary authority adopted by the Association.
- In the absence of the President and/or Vice President, or if the position becomes vacant, the Executive Committee shall preside at all Chapter meetings until the vacancy is resolved.



# GUNAA-DC Elections December

## Vice President

- Shall serve on the Executive Committee
- Shall preside at all meetings of the Chapter and the Executive Committee in the absence of the President or if the position of President becomes vacant.
- He/She shall perform such other duties as assigned by the President
- The Vice President shall have oversight of Chapter Committees
- The Vice President shall perform the duties prescribed by Association Bylaws and by the parliamentary authority adopted by the Association.

# GUNAA-DC Elections December

## Secretary

- The Secretary shall keep records of the meetings of the Chapter, Executive Committee, special meetings, and any other meetings of the general body of the Chapter.
- The Secretary shall report the proceedings of the Chapter and read all Executive Committee recommendations for consideration at chapter meetings.
- The Secretary shall be responsible for the distribution of correspondence to the chapter membership.
- The Secretary shall maintain content for the Chapter's public facing digital platforms.
- He/She shall perform such other duties as assigned by the President

## Treasurer

- The Treasurer shall have charge of all funds of the Chapter and shall submit to the Chapter President a detailed report of all receipts and disbursements prior to each chapter meeting.
- The Treasurer shall perform the duties prescribed by the Bylaws and by the parliamentary authority adopted by GUNAA.
- The Treasurer manages and oversees any auditing, budgeting, fund raising, and certification of financial statements.
- He/She serves as financial liaison between the Chapter and the Association.
- He/She shall also work with the President to prepare and submit an annual budget to the Executive Committee.
